**1) Competent Authority**

- i) Affidavit duly attested
- ii) Copy of allotment letter.
- iii) Copy of Possession certificate.
- iv) Copy of letter of approval of Building plans from PSIEC/GMADA/PUDA/MC
- v) Sanctioned building plan duly signed by approved architect and allottee. And marking of water supply lines in blue and of sewer lines in red.
- vi) Copy of NOC from Punjab Pollution Control Board.
